C. Consider Providing Additional Direction to Staff on Draft Upstream User Agreements

E. Consider Accepting Proposal for Fiscal Year 2015/2016 Financial Audit Services

Upon <u>motion</u> by Director Brittain, <u>second</u> by Director Terry and <u>carried by a 3 to 0</u> <u>vote</u>, the <u>Van Lant & Fankhanel</u>, <u>LLP</u> proposal for Fiscal Year 2015/2016 Financial Audit Services was accepted in the amount of \$22,500.

F. Consider Authorizing Expenditure for Automatic Meter Reading Phase 1 AND Authorize the General Manager to Execute the Appropriate Agreement Approved by District Legal Counsel

Upon <u>motion</u> by Director Bennett, <u>second</u> by Director Brittain and <u>carried by a 3 to 0</u> <u>vote</u>, the Board of Directors authorized the expenditure of \$42,192.10 for automatic meter reading phase 1 and authorized the General Manager to execute the appropriate agreement approved by District Legal Counsel.
